## Terms and Conditions

Before sending your booking form, make sure you contact us regarding availabilities.

Each booking is name specified and is only valid for one mobile-home or lodge tent.

Stays start at 3 pm and end at 10 am.

**Reservation will be effective after collection of the 25% deposit + 20 € booking fees and booking confirmation by mail or email within 10 days. This formal confirmation will have to be shown on arrival at the campsite.**

**The deposit is credited to the total amount of the stay. The remaining must be paid at the latest 30 days before arrival date. In case of formal cancellation** made more than 30 days before arrival date the deposit will not be returned. In case of cancellations made after this time, all the sums already paid for the stay will be retained.

An **insurance** for "Cancellation and Interruption of stay", optionally, is proposed in your contract. Affinity Gritchen our partner agrees to reimburse all or part of the stay only to customers who purchased the "Campez Couvert" insurance (see brochure and conditions on the camping website).

Clients must warn us of any late arrivals. If 24 hours after the booked arrival date (3 pm the next day), we have not been warned, reservation will be cancelled and all the sums already paid for the stay will be retained.

There will be no price reduction in case of late arrivals or early departure.

Clients and their party will have to register, with proof of identity, on arrival at reception.

No annex installation attached (eg tent.) is accepted on the location of the rental (mobile home or lodge tent).

Animals are allowed on site. They must be on a lead and never left alone on site. 1 & 2 category dogs are not allowed (guard or attack dogs, Rottweiler, Staffordshire Bull Terrier etc...)

Sheets, pillowcases, towels, household linen are not provided.

So that there is no litigation at the outset, it should upon arrival to check the general condition of the accommodation and its contents and note any observations in the inventory form given to the tenant upon arrival. This form must be delivered to the reception within 24 hours of arrival. After this time the camping will consider that renting corresponds with the inventory form.

Any breakage will have to be paid by the client. To that instance a 250 € deposit will be required at the beginning of the stay and returned on the last day after inventory in deduction for damages and/or missing items. To keep uniformity in the inventory it is not allowed to replace equipment damaged by items bought outside.

Cleaning the accommodation is the responsibility of the tenant, unless the tenant agrees with the cleaning service proposed by camping. A fee of 45 € will be retained, if the accommodation is not let perfectly clean.

Each person or visitor to the campsite is required to respect its rules and regulations.
