## Terms and conditions

Before to send your booking request, please consult us (website or phone) to know our availabilities.

### **Article 1 - Field of application of general terms and conditions of sale :**

These general terms and conditions govern all sales of stays made by the Camping Le Fun. They are an integral part of any contract between the campsite and its customers.

Each client acknowledges that they have been made aware of these terms and conditions prior to any booking of a stay, for himself and anyone participating in the stay.

### **Article 2 - Booking conditions**

#### 2.1 Price and payment:

A payment of 25% of the price of the stay must be paid in order to confirm your reservation, the balance will be paid no later than your arrival day.

All reservations are personal and cannot be transferred. The rental only becomes effective with our agreement and after receipt of the total amount of the stay (at your arrival) and booking fees.

For any unreported delay, the pitch becomes available 24 hours after the expected arrival date (12h the next day). After this period, and in the absence of a written message, the reservation will be null and all sums paid will not be refund.

#### 2.2 Modification of reservation:

No reduction will be made in the event of late arrival or early departure.

#### 2.3 Cancellation of stay :

In the event of cancellation the 25% payment will be retained by the campsite.

Booking fees and insurance costs (if the customer has taken out an insurance) are never refundable.

#### 2.4 Cancellation insurance:

We recommend you to take out cancellation and interruption insurance. Our partner Gritchen Affinity undertakes to reimburse all or part of the stay only to customers who have taken out Campeze Couvert insurance (see conditions on the website)

2.5 Pricing: The prices shown are subject to change. The campsite reserves the right to change the rates at any time. The rate applicable to the stay is the rate in effect on the day of reservation and this subject to availability.

### **Article 3 - Course of the stay**

#### 3.1 Arrivals and Departures:

Arrival from 1:00 p.m. to 7 p.m., Departures between 8 a.m. and 11 a.m.

#### 3.2 Caution:

A caution of 10 € will be requested for the pass allowing the opening of the barriers.

#### 3.3 Departure:

Departure is till 11.00 am. If you leave after hours, the campsite will be entitled to charge you for an extra night.

Any extension of the stay must be made before the scheduled departure date.

#### 3.4 Animals:

Animals are accepted (2 animal per pitch). You must declare your animal at your arrival and there will be an additional cost per night to pay.

They must be kept on a leash and must not be left alone on the locations. Category 1 and 2 dogs are prohibited.

Up to date vaccinated document required.



### 3.5 Others:

The number of people per pitch is limited to 6, children included.

### 3.6 Internal regulations:

Anyone who has booked a stay, as well as visitors, is required to respect the internal rules. As the law requires, you must adhere to our internal regulations, deposited at the prefecture, displayed at our reception, available on the website and a copy of which will be given to you on request.

### **Article 4 - Responsibility**

The Campsite declines all responsibility for damage to the camper-caravaner's equipment which is of its own actions; insurance for your equipment in terms of civil liability is compulsory (FFCC, ANWB, ADAC ...).

### **Article 5 - Applicable law**

These general conditions are subject to French law and any dispute relating to their application falls under the jurisdiction of the *Tribunal de Grande Instance* or the *Narbonne Commercial Court*.

### **Article 6 - Mediation of consumer disputes**

The customer has the right to use the mediation service offered by FUN CAMPING free of charge. The mediator thus proposed is CM2C.
